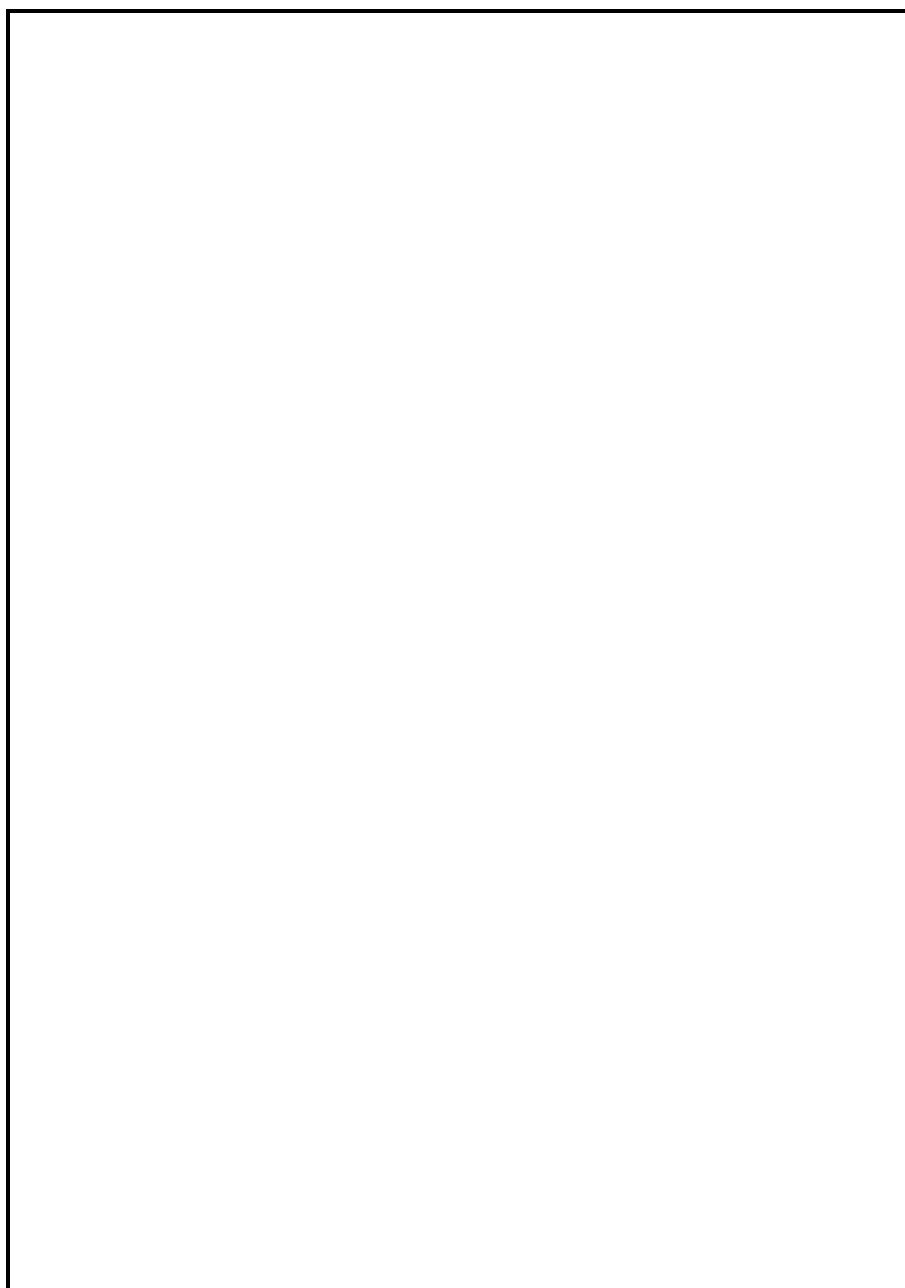
At any time within twelve months after sealing of a patent, any person interested who did not oppose the grant of the patent may apply to the comptroller for an order revoking the patent on one or more of the grounds upon which the grant of the patent could have been opposed. These grounds are: insufficiency; prior publication/claiming/use; obviousness; not an invention; and for convention applications, the application not made in time. The applicant for revocation must file a statement setting out his interest, full details of the case on which he relies and the relief sought. The patentee must file a counterstatement setting out his response. The application is heard by the comptroller and there is an appeal to the Patents Appeal Tribunal or the Patent Court depending on whether the appeal is heard before or after 1 June 1978 respectively. There is an appeal from either court to the Court of Appeal. If the appeal is allowed then the decision of the Patents Appeal Tribunal or Patents Court is reversed.
