code meaning

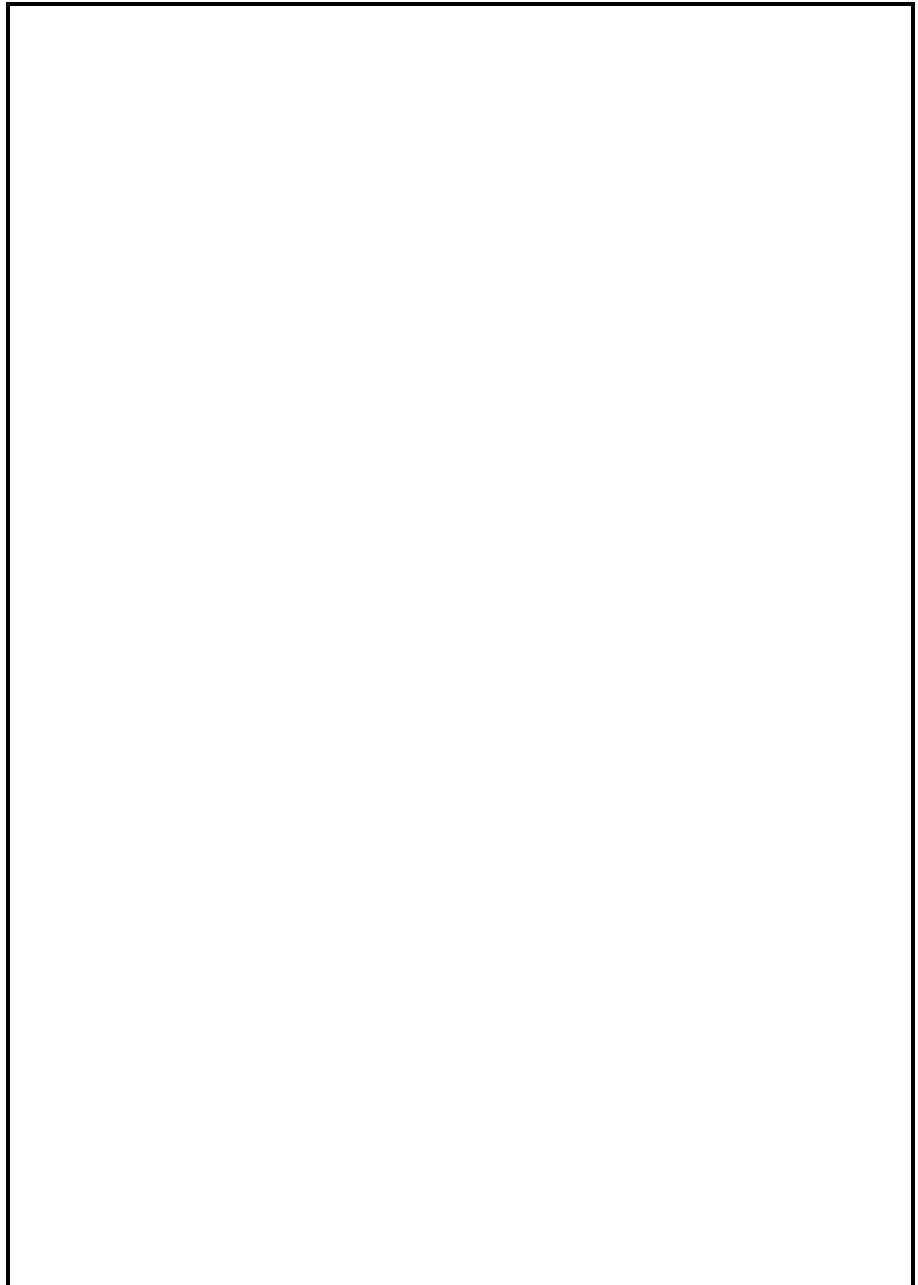
At any time after an entry for licences of right has been made in the register the proprietor may apply to the comptroller for cancellation of the entry. When the application is made it must be accompanied by the balance of renewal fees which would have been payable if an entry had not been made. The comptroller may cancel the entry if he is satisfied that there is no existing licence under the patent or that all licensees consent to the application. The application is advertised in the Official Gazette and any person may oppose the application within three months of the date of the Gazette. An application to cancel an entry may be made within three months of the date of the entry by a person who claims that the proprietor of the patent was precluded by a contract from granting licences. The application must be supported by a statement setting out the applicant's interest and the facts relied upon. In the event that an entry is cancelled then this is advertised in the Official Gazette.
